

We celebrated International Women's Day, alongside Multicultural Services Centre WA. We were lucky enough to have the Hon Dr Anne Aly MP present a speech where she shared her perspectives on ensuring equality for all women, particularly those from Culturally and Linguistically Diverse Communities. Furthermore, we were blessed to have Disability Services Manager at MSC, Linda Vetoor, speak about gender equity in the workplace and fostering inclusive work environments.

National Anti-Racism Framework Consultation

07/03/2024

The Ethnic Communities Council of WA facilitated a consultation on 7th March 2024 to inform FECCA's submission to Australia's National Anti-Racism Framework, specifically focusing on the experiences of culturally and linguistically diverse (CaLD) individuals with disabilities. This initiative aimed to capture firsthand accounts of racism faced by these communities, particularly those with disabilities, to refine anti-racism policies and ensure they address real-world challenges.

Participants included people living with a disability, their support workers, and interpreters, employing a discussion-based methodology. Information was gathered through written records, digital forms, and observations, ensuring a comprehensive compilation of insights.

Key findings highlighted systemic barriers across healthcare, employment, housing, and community services. Significant issues included language and communication barriers in aged care and disability services, discrimination in employment practices, and challenges in accessing healthcare due to inadequate interpreter services. These factors contribute to the compounded discrimination faced by CaLD individuals with disabilities.

Recommendations focus on a multi-sectoral approach to address these disparities:

- 1. Implementing language support policies in aged and disability care
- 2. Expanding professional interpreter services, particularly for underrepresented dialects.
- 3. Providing cultural competency training to reduce discriminatory practices.
- 4. Encouraging inclusive hiring practices and promoting diversity in workplaces.
- 5. Enhancing healthcare accessibility with better support for non-English speakers.
- 6. Tackling discriminatory practices in housing and improving access to services for non-English speaking women with disabilities.

The consultation underscores the need for targeted policy reforms and practical measures to address the intersectional nature of racism and discrimination, ensuring that CaLD communities with disabilities receive adequate support and recognition in anti-racism efforts

DIVERSE VOICES, COMMON CAUSE | 30/04/2024

ECCWA hosted a workshop titled, "Diverse Voices, Common Cause", an interactive forum to discuss experiences of racism within CaLD and Aboriginal communities. We offer a big thanks to Senior Noongar man, Jim Morrison, and Emeritus Professor of Sociology, Andrew Jakubowicz, from the University of Technology Sydney, for offering extremely valuable insights and commentary on the existing issues our diverse communities face. Capacity building, led by Sharan Kraemer, was had amongst our attendees, to discuss concerns in the workplace regarding racism, and the barriers faced by those in CaLD and Aboriginal communities. Our attendees enjoyed networking afterwards to continue enriching discussions on how to combat racism and work together with the CaLD and Aboriginal communities, not only in Western Australia, but also Australia.

PERCEPTIONS OF ELDER ABUSE IN CULTURALLY AND LINGUISTICALLY DIVERSE COMMUNITIES

ECCWA is taking part in the CaLD Elder Rights project, "Perceptions of Elder Abuse in Culturally and Linguistically Diverse Communities" announced by Minister for Seniors and Ageing Hon Don Punch MLA today. The project is in conjunction with Umbrella Multicultural Community Care Services Inc, Legal Aid WA, and funded by the Department of Communities. We have participated in information sessions with other community representatives from CaLD backgrounds to discuss elder rights and elder abuse.





AUSTRALIAN ELECTORAL COMMISSION

Understanding Community Education and Support for CALD Communities in Australia

On 4 April 2024, representatives from the Ethnic Communities Council of Western Australia (ECCWA) joined a crucial roundtable discussion with the Australian Electoral Commission (AEC) and 11 community leaders to address the challenges of low voter turnout and high vote informality among culturally and linguistically diverse (CALD) communities. The session provided a platform to evaluate the current awareness of the electoral process and the AEC's role within these communities. Participants openly discussed the barriers that impede community understanding and engagement with the electoral system. The dialogue also explored effective strategies through which the AEC can enhance community members' comprehension of electoral mechanisms and encourage active democratic participation. This meeting highlighted the need for tailored approaches to break down the complexities of the electoral process, ensuring all community members can contribute to Australia's democratic landscape.

ACCAN CONSUMER ADVISORY COUNCIL | 27/03/2024

March 2024, representatives from the Ethnic Communities Council of Western Australia (ECCWA) participated in the Australian Communications Consumer Action Network's (ACCAN) Member's Advisory Forum. The forum serves as a platform to inform ACCAN members about ongoing initiatives and gather input to shape future policy directions.

Universal Service Obligation Reform

A key topic was the Australian Government's reform of the Universal Service Obligation (USO), which ensures access to standard fixed landline phone services and public payphones across Australia. ACCAN highlighted the shift in consumer expectations, emphasizing the necessity of both voice and data services in modern life. Concerns discussed included delays in fault rectification, especially in remote areas, and the need for improved communication regarding Telstra's maintenance visits. 3G Network Shutdown

The impending shutdown of Telstra and Optus's 3G networks was also a major discussion point. Set for mid and late 2024, this shift aims to make room for more advanced technologies but raises concerns about the accessibility of emergency services. With certain older 4G devices potentially unable to connect to emergency services, the forum stressed the importance of public awareness and support for low-income consumers needing device upgrades. Scams Reduction Initiative

ACCAN expressed ongoing concerns regarding the prevalence of scams via SMS and phone calls. An upcoming SMS ID registry, which ACCAN argues should be mandatory, aims to mitigate these risks by helping consumers identify fraudulent messages. Discussions also covered the challenges in assessing the impact of scams, especially within CALD communities, due to their evolving nature.

EXTERNAL BREAST PROSTHESES REIMBURSEMENT PROGRAM (EBPRP)

Content Warning

This article discusses topics related to breast cancer, which might be sensitive for some readers.

Breast cancer remains one of the most common cancers affecting women worldwide. As we explore the impacts, treatments, and personal stories associated with this condition, we also understand the emotional weight these discussions can carry. Verna Kanagarathnam, Baily Fernandez and Dr Sadhana Bose participated in an evaluation of the External Breast Prostheses Reimbursement Program (EBPRP), which is an important program that reimburses women with breast cancer for the cost of their prosthesis after mastectomy. This evaluation was undertaken for the Cancer Policy and Projects Branch of the Department of Health and Aged Care. A key component of the evaluation was to understand the experience of those from CALD backgrounds, to ensure that the program meets the needs of this population, recognising that CALD women often face additional challenges in their management of breast cancer.

GENESIS

Over the past few months, the Genesis Project has been engaging significantly with women from CaLD communities, running 5 women support groups in North Perth, Mirrabooka, Bentley, Ellenbrook and Gosnells. conducted were equally impactful, with the Bentley group engaging in a variety of sessions, from Zumba to job interview skills. In the Gosnells group, which is in its formative stage, essential support was provided focusing on local employment pathways and skill development, assisting 15 new participants. Furthermore, the project successfully conducted First Aid and CPR training, certifying 45 women and enhancing their employability and personal growth. The Mirrabooka sessions reached about 30 women weekly with over 10 different service providers contributing, while the newly inaugurated Ellenbrook group provided a secure environment for 20 weekly participants. In addition, 30 participants took part in the Digital Inclusion project, significantly boosting their digital literacy. Collectively, these focus groups exemplify the Genesis Project's dedication to empowering CaLD women by enhancing their skills, expanding their networks, and integrating them into the community through wellstructured and culturally sensitive activities

SPEAK MY LANGUAGE

The Speak My Language project was a follow on from the first phase that had been undertaken by ECCWA in conjunction with ECCNSW relating to CaLD people with disability. This phase of the project was to arrange broadcasts with as many broadcasters as was possible of a series of programs that were designed specifically for CaLD people with disability. There have been 18 programs that have aired, focusing on a number of areas of involvement in community of this cohort of people.



CCYP Belonging Across Borders Survey



Commissioner for Children and Young People WA has launched a new survey titled 'Belonging Across Borders'. The survey was created to explore the experiences of young people from culturally and linguistically diverse (CaLD) backgrounds who have immigrated to Western Australia or have parents who did. Over 90,000 children and young people who live in WA were born outside of Australia, which is approximately 15% of this age group's population.

The survey will close on Monday 3rd June at 12pm, and the findings will be released publicly later in the year.

Australian Red Cross: Safety Net

Australian Red Cross has funds to support people on temporary visa's in extreme financial hardship. For many, this is the last line of support after they have been turned away from other services due to eligibility criteria. The program is Safety Net. They also offer case work support

They offer case work support, or if you are already providing case work support, they can offer your client up to three financial assistance payments whilst you continue to support them.

How can Australian Red Cross help?

We can provide payments for urgent financial needs. We may also support with casework and ongoing financial payments for people in particularly difficult situations.

What are the eligibility requirements?

- · Live in Australia.
- Be unable to access Commonwealth Government income support.
- Be seeking asylum, hold a temporary visa or have an uncertain visa status.
- Have no or very limited income, savings or community support.




